### Becky Fights Wall Street Banks

Becky Harris is not your typical Republican. In her law practice, she represents homeowners in their fights against Wall Street banks. As our State Senator, she will fight for us in our battles against Wall Street banks and other powerful special interest groups.

### Becky Fights for Our School Children

### JUSTIN JONES FIGHTS FOR THEM

- ✗ *Justin Jones is an attorney who was paid by a Wall Street bank to represent it in the Nevada Supreme Court.<sup>1</sup>*
- ✗ *Justin Jones then wrote legislation that exempts the same Wall Street bank from Nevada's "Homeowners Bill of Rights".<sup>2</sup>*
- ✗ *Justin Jones took \$14,500 in gifts and campaign contributions from a foreign gold mining company.<sup>3</sup>*
- ✗ *Justin Jones refused to support legislation that would have increased the gold mining tax to fund education.<sup>4</sup>*
