UNLV disowns its own study on margin tax

UNLV is wringing its hands over an economic study done by its Center for Business and Economic Research.

The center released the study on Tuesday and reported that the Education Initiative, also known as the margin tax, was a way to earn the state up to \$862 million for Nevada's K-12 education system while creating more than 13,000 jobs in 2016.

The center's report "does not represent the position or views of the university," UNLV acting President Donald D. Snyder said in a media release on Thursday.

"UNLV did not commission the study," he said. "While CBER is a center within UNLV, it does not form part of the university's day-to-day operations nor is it functionally aligned with our broader initiatives. It is an independent center."

Snyder did not criticize the methodology used to conduct the study, but asked the nonpartisan think tank Brookings Institute to review its findings.

The initiative has been a political hot button since the end of the 2013 legislative session and the findings of the new study are contrary to other reports about the tax.

The Nevada Policy Research Institute conducted a study that found the tax will raise \$862 million per year while costing the state 1,640 jobs and cutting investment by \$7.1 million a year. The institute is opposed to the tax.

Other UNLV faculty have authored or co-authored other reports on the tax, but the university says it does not have a position on the initiative.

The tax is a proposed 2 percent tax hike on businesses earning more than \$1 million in revenue per year and a result of lawmakers not being able to find a way to agree to creating more revenue streams for Nevada's public education system, which ranks last in the country.

Supporters of the tax collected more than 100,000 signatures from around the state to get the measure on the Nov. 4 ballot.

Dan Hart, campaign manager for the Education Initiative, asked the university's Center for Business and Economic Research to conduct the study because it would be "independent" from the partisan politics of the measure.

It is "extraordinary" that UNLV is questioning its own study, he said.

"I worry that there are politics involved in this," he said.

The tax has seen little support from Democrats and other left-leaning organizations. The AFL-CIO at first touted the measure but then dropped its support. The only group backing the tax is the state's teachers union.

Groups such as the Las Vegas Metro Chamber of Commerce, the Nevada Association of Realtors, the Nevada Mining Association and the Nevada Resort Association oppose the tax.

In fact, some UNLV faculty and alumni have authored or co-authored reports that demonstrate a negative impact from the margin tax. The university itself does not take positions on public-policy issues.

"The university is a community of more than 30,000 students, faculty and staff," said Snyder. "I have always said that to be a great community, you need a great university connected to that community. That connection requires that we have all reasonable assurance that research findings are strongly supported by methodology and that's why I've asked for feedback from Brookings."

He decided the El Patio Ballroom in Reno, after it was determined that a large tent would be a hazard. After some negotiations and clarifications with the City and the Fire Department, Goldwyn set up a theater in the ballroom, but had to fix the chairs to the floor, which he did. Goldwyn got support from friends and other independent producers. To win favor with the locals, Goldwyn donated profits to the show to the local Red Cross. Actress and co-founder of United Artists, Mary Pickford made the trip from California to support Goldwyn. On August 22, 1944, the movie Up In Arms was shown in Reno, NV outside of the big studio theaters. Pickford talked about the theater monopoly and how it stifled creativity, and read a telegram that arrived from Walt Disney:

UNLV REQUESTS FURTHER ANALYSIS OF CBER MARGIN

TAX REPORT

University president calls upon The Brookings Institution for review

LAS VEGAS – August 21, 2014 – The University of Nevada, Las Vegas (UNLV) has responded to a report from the Center for Business and Economic Research (CBER) that touted the benefits of a proposed Nevada Margin Tax on the November ballot. Three other separate economic analyses previously released outlined the financial harm the state would experience if the tax were implemented.

"The CBER report does not represent the position or views of the university," said President Donald D. Snyder. "UNLV did not commission the study," he added. "While CBER is a center within UNLV, it does not form part of the university's day-to-day operations nor is it functionally aligned with our broader initiatives. It is an independent center."

About two thirds of the funding for CBER comes from contract research and data analysis work that CBER performs for clients, as well as gifts, sponsorships and subscriptions to CBER services.

Executive Vice President and Provost John Valery White, who serves as the university's Chief Academic Officer, noted that other economic experts have expressed skepticism about the methods and conclusion of the research.

"We encourage our faculty members to offer analysis of significant policy issues; however, it should be noted that other UNLV faculty have expressed different opinions on the margin tax," said White. "The purpose of academic research is to begin or continue a conversation on important topics and to allow others to critique methodology or findings in order to move knowledge forward," he added.

White said that Mary Riddel, professor and chair of the Economics Department at UNLV and former interim Director for CBER, immediately raised concerns about the report and the modeling strategy used. UNLV economics professor Alan M. Schlottmann also questioned aspects of the study.

Based on the feedback from Provost White and the two UNLV economic professors, President Snyder has requested The Brookings Institution, based in Washington, D.C., review the report and provide an analysis on its merit and quality.

As with any university, UNLV faculty may enter into independent contracts with clients and provide their services for a fee. In fact, some UNLV faculty and alumni have authored or co-authored reports that demonstrate a negative impact from the margin tax. The university itself does not take positions on public-policy issues.

"The university is a community of more than 30,000 students, faculty and staff," said Snyder. "I have always said that to be a great community, you need a great university connected to that community. That connection requires that we have all reasonable assurance that research findings are strongly supported by methodology and that's why I've asked for feedback from Brookings."

UNLV REQUESTS FURTHER ANALYSIS OF CBER MARGIN TAX REPORT

University president calls upon The Brookings Institution for review

LAS VEGAS – August 21, 2014 – The University of Nevada, Las Vegas (UNLV) has responded to a report from the Center for Business and Economic Research (CBER) that touted the benefits of a proposed Nevada Margin Tax on the November ballot. Three other separate economic analyses previously released outlined the financial harm the state would experience if the tax were implemented.

"The CBER report does not represent the position or views of the university," said President Donald D. Snyder. "UNLV did not commission the study," he added. "While CBER is a center within UNLV, it does not form part of the university's day-to-day operations nor is it functionally aligned with our broader initiatives. It is an independent center."

About two thirds of the funding for CBER comes from contract research and data analysis work that CBER performs for clients, as well as gifts, sponsorships and subscriptions to CBER services.

Executive Vice President and Provost John Valery White, who serves as the university's Chief Academic Officer, noted that other economic experts have expressed skepticism about the methods and conclusion of the research.

"We encourage our faculty members to offer analysis of significant policy issues; however, it should be noted that other UNLV faculty have expressed different opinions on the margin tax," said White. "The purpose of academic research is to begin or continue a conversation on important topics and to allow others to critique methodology or findings in order to move knowledge forward," he added. White said that Mary Riddel, professor and chair of the Economics Department at UNLV and former interim Director for CBER, immediately raised concerns about the report and the modeling strategy used. UNLV economics professor Alan M. Schlottmann also questioned aspects of the study.

Based on the feedback from Provost White and the two UNLV economic professors, President Snyder has requested The Brookings Institution in Washington D.C. review the report and provide an analysis on its merit and quality.

The focus of the conversation agreed to is a broad range of topics: new fall semester and accompanying registration numbers, initial budget approval for UNLV School of Medicine, new campus stadium project, UNLV Foundation dinner, and the request to have a peer review as such of the Margin Tax report from the

Center for Business and Economic Research. The timing of the appearance is driven by the start of the new fall semester and the progress of the various initiatives.
