Dear Mr. Tyree:

This letter concerns the video and TV spot your organization paid for and released regarding candidate and incumbent State Senator Michael Roberson, District 20. The video is posted on YouTube.com and can be accessed here: https://www.youtube.com/watch?v=cBA-UzmJ39U. Furthermore, FCC records indicate that the TV spot appeared on all four major broadcast stations in the Las Vegas area during the week immediately preceding the recent Primary Election (June 3-9, 2014) and that nearly \$60,000.00 was spent to air the TV spots (see enclosures). The video explicitly discloses that it was paid for by your organization – Team Nevada Engaged.

While Team Nevada Engaged registered with the Secretary of State's Elections Division as a non-profit corporation engaging in political activity, it has <u>not</u> filed any Contributions and Expenses (C&E) Reports. It is the opinion of this office that the video is express advocacy, as defined in NRS 294A.0025, against candidate Roberson. As such, your organization is required to file the applicable C&E Reports disclosing contributions received and expenditures made in excess of \$1,000. See, NRS 294A.140 and 294A.210.

The Secretary of State, as the Chief Elections Officer for the State of Nevada, is responsible for enforcement of the election laws contained in Title 24 of the Nevada Revised Statutes, of which these sections are a part. As such, please respond to this letter explaining your position why your organization was not required file the corresponding C&E Reports. Alternatively, you may file the appropriate C&E Reports and contact this office to discuss resolution of the civil penalty for late filing as set forth in NRS 294A.420(3).
