**COMPLAINT**

Complainant files this complaint, under penalty of perjury, with the Federal Election Commission against Mr. Niger Innis, the Niger Innis Action Fund, the Niger Innis for Congress Exploratory Committee, and Niger Innis for Congress campaign, for violation of federal laws and regulations pertaining to exploratory committees or “testing the waters” for federal candidates. I am a registered voter in Nevada Congressional District 4.

Since the summer of 2013, Mr. Innis has been touting and planning a run for Congress in Nevada’s District 4. See Exhibit 1, “NRCC Proposal.” Apart from appearing to plan a fully-coordinated campaign with local and state candidates, which is against laws and regulation in and of itself (see page 2, “Innis will boldly lead a candidacy...” and page 7, laying out coordination plans with other candidates and officials), the Proposal shows that Mr. Innis had done much of the analysis necessary to determine whether to run in NV4 as early as July 2013.

Instead of announcing a candidacy and filing appropriate paperwork with your Commission, or even putting together a brief “testing the waters” program as outlined and recommended in the guides and information available through your printed and web-based materials, Mr. Innis appears to have formed one, and perhaps two, “exploratory committees,” or funds, to begin raising monies, and he began to appear regularly on Nevada media and at party or activist functions discussing his intent to run for Congress. This lasted throughout the summer, fall, and now winter, 2013-2014.

During the fall, Mr. Innis set up a website for his “Action Fund,” that included a portal for accepting contributions. See Exhibit 2. These are not, as described in the FEC’s guide materials, raising enough money from a few trusted persons to do preliminary testing of the waters; it is solicitation of contributions from unknown persons in support of a run for Congress already planned and in motion. The website is titled “Draft Niger Innis,” but of course is “Paid for by the Niger Innis Action Fund.”

In November 2013, the "Niger Innis Congressional Exploratory Committee" planned, advertised, and encouraged attendance and contributions at a high-level fundraising event. See Exhibit 3. The fundraiser was held at the home of Republican backer Victor Chaltiel, and was hosted, among others, by Sheldon Adelson. It featured special guest and former Presidential candidate Herman Cain, and suggested contributions to Mr. Innis in the full amount of federal limits. Mr. Innis informed the local newspaper that he expected to raise at least \$50,000 at this event. See Exhibit 4. Mr. Innis later posted video of Mr. Cain's speech to contributors at the event on his own website. See Exhibit 5.


Nevada's Fourth District has a few hundred thousand registered voters, from my review of public records. Given the work apparently put into thinking about a run for office shown by the July 2013 Proposal, there do not seem to be legitimate, ongoing "testing the waters" activities—even including polling of travelling, that would require big-dollar fundraisers, \$50,000 in seed money, or a website soliciting contributions from persons over the internet—and especially not over a six or seven month period.

According to your publicly-available materials on "testing the waters," it is clear to me that Mr. Innis has made or authorized statements regarding his intention to run, long before filing for office; used general public political advertising to publicize his intention to campaign; raised far more money than necessary to test the waters, and conducted his campaign activities over a protracted period of time—from last summer through the present.

I am aware that candidates have faced discipline from the FEC previously for abusing your "testing the waters" rules. I believe in this instance, discipline is warranted, as my neighbors and friends in Nevada District 4 deserve better transparency from our potential leaders.

Please investigate this matter at your convenience. Thank you very much.

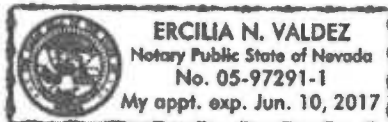



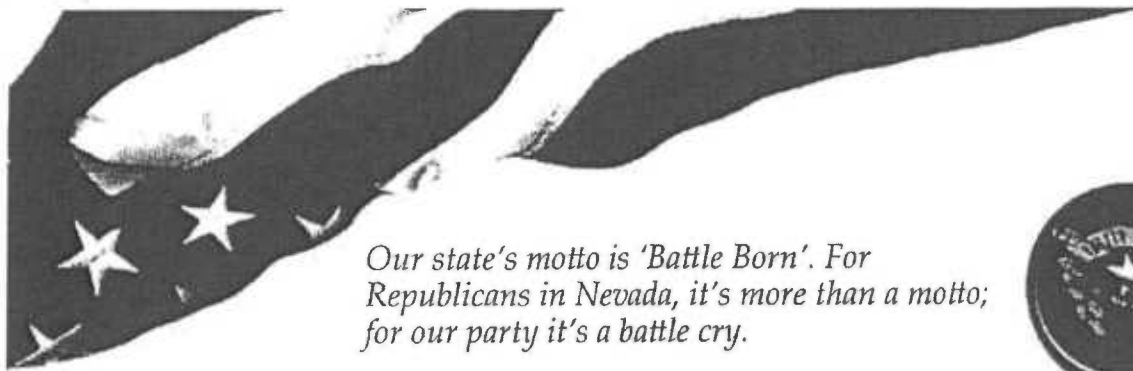

## OVERVIEW

If 2012 was the year of awakening for the Republican Party, then 2014 is the year of opportunity and transition. Nowhere will this be more evident than in the great battleground state of Nevada.

Our state's motto is 'Battle Born'. For Republicans in Nevada, it's more than a motto; for our party it's a battle cry.

Without a U.S. Senate race, the focus will fall upon the congressional races. And no race holds greater promise, a larger upside, for the Republican Party than CD04. There are so many factors that make this a winnable race.

That leads to the most important factor of all: the candidate in CD04. Nigier Innis is not only the candidate but the right candidate, at the right time, to bring together a blended coalition of registered voters who run the gamut of ethnic diversity.

In a congressional district whose population is comprised of roughly 40 per cent minorities (2010 census), the opportunity to extend the Republican Party's reach into this critical demographic in terms of registering new voters, converting existing voters, identifying and re-engaging inactive voters, and garnering a substantial crossover vote is genuine and attainable.

The groundwork for this effort in Nevada was laid in 2012. Both Hispanic and Black voters showed small increases in the percentage that voted for the Republican presidential candidate. In CD04, a significant, targeted minority voter registration effort will seek to improve upon that trend.

### Race & Ethnicity change since 2008

The white vote went to Mr. Romney, mostly by wide margins. But Hispanics and Asians moved toward Mr. Obama, continuing their consolidation as Democrats.

## Building a "New" Republican Voter Base to Win CD04.

*The numbers are pretty clear and facts are facts.*

On election day last November, the registration numbers in CD04 heavily favored the Democrat candidate.

■ In the entire district, not including non-partisan/other voters, the Democrats held a 17 per cent registration advantage, with over 41,000 more voters.

■ In Clark County, which encompassed over 86 per cent of the registered voters in the district, the Democrats held a 22.5 per cent registration advantage, a gap of almost 48,000 voters.

■ In Clark County, the margin of victory was only 12.5 per cent, meaning Danny Tarkanian cut the gap by almost half.

Through solid Republican turnout in the rurals, most likely a decent crossover vote and support among 'Other' voters, Tarkanian was able to overcome the D vs. R gap and cut Horsford's margin of victory to single digits. Unfortunately, just not enough to win.

Now, imagine a Republican candidate that can not only hold the vote in the rurals, but also make significant progress in closing the registered voter gap and take a significant chunk of voters away from the Democrats in the urban precincts.

All while increasing the minority registered voter base within the Republican Party.

## STAGE ONE

### NEW AMERICA

*Kickoff Date: September 1, 2013*

New America will close the voter registration gap in two ways:

1

A grassroots strategy identifying and contacting non-registered voters in CD04 via phone, mail and at the door. Personal contact to ID potential Republican voters and then following up to get them registered.

2

Specifically directed to minorities, engage them in the community through events, churches, schools and more. Also, the Hispanic community will be addressed via a conservative radio talk show in Spanish. The goal will be to expose the minority communities to our conservative view, familiarize them with our philosophy, make the connection that our values and goals match theirs and then register them to vote.

## STAGE TWO

### NEW AMERICA & JOIN AMERICA

This dual effort will essentially continue the voter ID and registration program initiated in CD04 by New America, just with the added assets of Join America. It will particularly strengthen the minority outreach efforts for voter registration.

The additional contacts and resources of Join America, when combined with New America, will greatly enhance the opportunity to close the D vs. R registration gap in CD04, driven by new Republican minority voters.

## STAGE THREE

### INNIS FOR CONGRESS CAMPAIGN

Under the direction of campaign consulting firm First Tuesday and voter outreach specialists Grassroots Strategists, the voter registration will continue as part of the campaign's voter ID and grassroots effort.

The ground game will be an integral part of the Innis for Congress campaign and will begin immediately.

With a current (June 2013) voter registration gap of 43,000 district-wide and almost 50,000 in Clark County, the goal will be to significantly reduce it by the end of the year. The vast majority of those will be new registers that are minorities.



## Up and down The Ballot Support

**M**any campaigns at the top of the ballot treat their brethren down the ballot as 'lesser' races that they believe should be there primarily to support their candidacy.

Many times these state and local candidates are used for their resources, especially volunteers, to prop up their efforts, sometimes to the point of coercion.

It's this 'top of the ballot rules' mentality that has derailed many candidates and races.

Innis for Congress has the exact opposite philosophy. Building a foundation of strength actually begins at the bottom, with emphasis on all state and local races, that feed into the national campaigns.

Campaign integration in this race will begin with CD04 not at the top, but in the middle, as a hub, serving as a central source of strategy and activity, feeding and sharing with any race that has an impact. This mutually beneficial approach to campaign cooperation will strengthen all races in the circle, which will naturally then extend to the national race they are connected to.

The second part of the Up and Down the Ballot

strategy will involve our recruitment of minority candidates to fill as many of the Republican slots as possible. These won't just be placeholders or sacrificial lambs. These will be carefully

considered candidates who will fit the voter profile of the district they are running in. Good, strong minority candidates who are

appropriate for their constituency and will bring a solid Republican message in an effort to bring these voters to the party.

Most importantly, they will campaign hard and present a challenge to their Democrat counterparts, incumbent or not. Every contested race we can

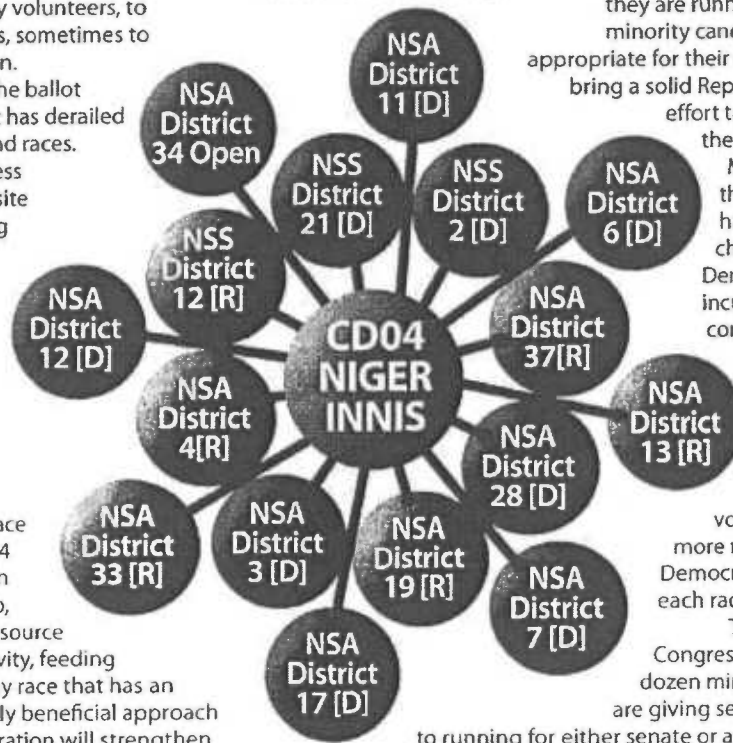
run at the state assembly and senate level will mean more registered Republicans, more voters considering voting Republican and more resources that the Democrats have to dedicate to each race.

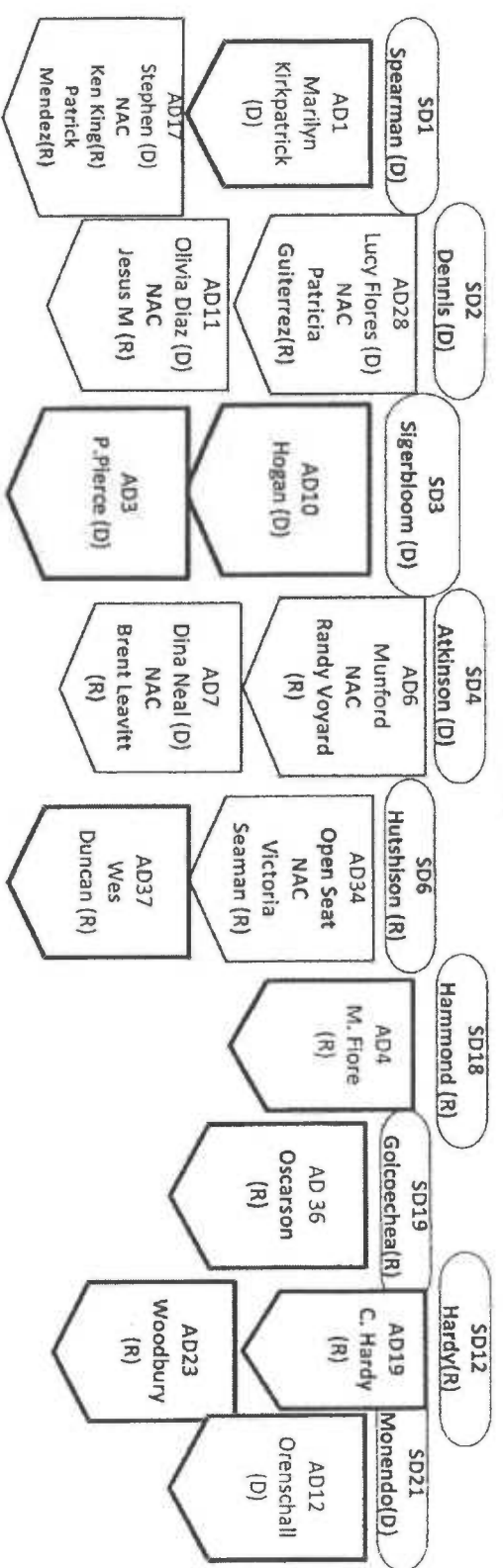
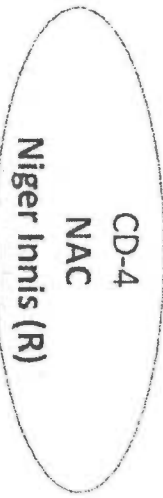

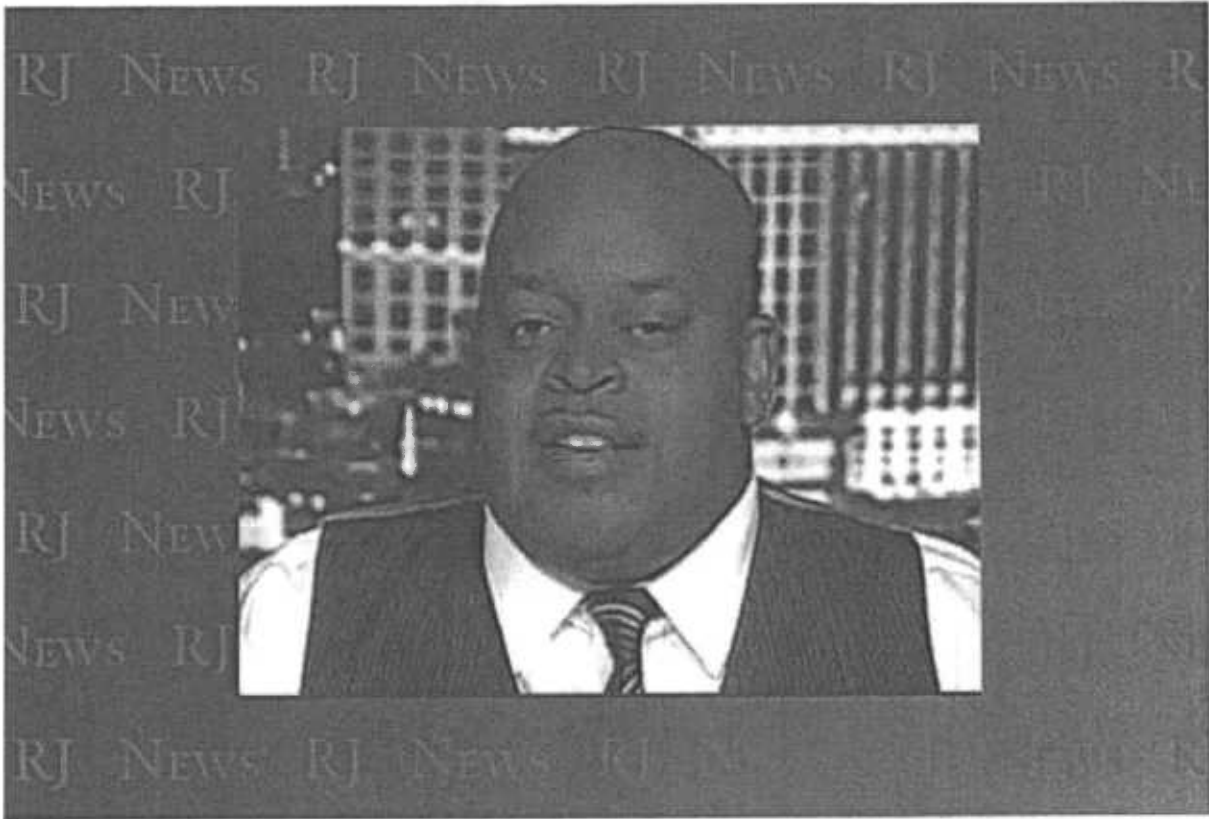

## Tea Party leader Niger Innis weighs Horsford challenge



Niger Innis, a Tea Party leader and conservative African-American, could be in line for campaign support to mount a challenge to Rep. Steven Horsford, D-Nev. GOP money man Sheldon Adelson on Tuesday helped raise

GOP money man Sheldon Adelson on Tuesday helped raise campaign cash for a potential challenger to Rep. Steven Horsford, D-Nev., the freshman congressman representing Nevada's newest district, which includes northern Clark County.

Niger Innis, who is exploring the congressional run, is a Tea Party leader and conservative African-American. He said he believes in immigration reform and in attracting more diverse people to the Republican Party. He calls himself a hybrid breed of politician who can appeal to minorities across party lines and reach non-partisan voters who decide close races.

Members of the Republican Party have started to realize they must attract more young voters and minorities to survive and win elections as national demographics change, Innis said. But he contends the GOP hasn't done enough to attract voters beyond its reliable older, white race base, mostly in rural parts of the country and Nevada.

The Republican Party has to be more effective in reaching out to a more diverse population," Innis said in an interview. "They are talking the talk. They're even thinking the talk. And that's good. That's progress. But they have to walk the walk."

Innis, 45, sees himself as a bridge to minority voters in Nevada's Congressional District 4, which is 54 percent non-white. Latinos make up about 27 percent of its population, African-Americans 16 percent, and Asians 8 percent. The district covers most of northern Clark County, parts of Douglas and Lyon counties, and all of Esmeralda, Lincoln, Mineral, Nye and White Pine counties.

Innis, the national spokesman for the Congress of Racial Equality, which his father heads, works to help minorities assimilate in U.S. society, including by learning English.

As the national outreach director of TheTeaParty.net, Innis has met with members of Congress to promote an eight-point immigration plan that includes tighter border security, assimilation and other measures to allow immigrants to become U.S. citizens. The Tea Party group doesn't support the current Senate "gang of eight" proposals, however.

More than 125,000 Tea Party members have signed on to the group's immigration principles so far.

Innis said Republicans should embrace immigrants, who built the United States.

"You have some members within the Democratic Party that demagogue the issue of immigration and use it as a political weapon," Innis said. "I'm going to confront that."

A native of New York, Innis has lived in Nevada since the end of 2007. He has been very active in politics, including in 2012. He supported Herman Cain's presidential bid until the conservative Republican dropped out of the race. Then Innis backed the eventual GOP nominee, Mitt Romney, who lost badly to President Barack Obama, in Nevada.

Innis' ability to raise money will determine whether he officially runs for Congress, he said. Also, he wants to avoid a primary. Assemblyman Crescent Hardy, R-Mesquite, also is considering a bid for Horsford's seat.

Tuesday night's fundraiser at Victor Chaltiel's Las Vegas home asked for contributions of \$500, \$1,000 or the maximum federal limit of \$2,600 for members of the host committee. Chaltiel, a Republican, lost the race for Las Vegas mayor in 2011.

Adelson and his wife, Miriam, are both members of the host committee. During the 2012 elections, the Sands Corp. chief and his wife donated more than \$100 million to GOP candidates and causes, more than any other individuals. Other host committee members include Jeb Bush, Jr., Paul Lowden whose wife, Sue Lowden, is running for lieutenant governor, and Amy Tarkanian, whose husband, Danny Tarkanian, lost the congressional race to Horsford in 2012.

Herman Cain also was scheduled as a special guest at the fundraiser, which is expected to attract more than 200 people and raise at least \$50,000, according to Innis.

Innis said he needs to raise \$2 million to be competitive against Horsford, who had \$117,682 on hand at the end of September after raising \$477,233 for his campaign so far this year, according to the Federal Election Commission.

As the incumbent, Horsford, 40, the first African-American from Nevada to serve in Congress, has the advantage in the race. He also can count on more voters to tap with Democrats outnumbering Republicans in the district, 144,424 to 101,440, according to the Secretary of State website. Another 53,563 registered voters are non-partisan. Most live around urban Las Vegas.

David Damore, a political science professor at the University of Nevada, Las Vegas, said Horsford will be hard to beat even though there's no high-profile presidential or U.S. Senate race to lift him. The congressman has been spending a lot of time in rural parts of his district, where he's less widely known, to build support, Damore notes.

"They're not taking that (the rurals) for granted," Damore said of Horsford's campaign. "He's been doing everything he should be doing as an incumbent."
